

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets on a corporate level. Wellspect has committed to Science Based Targets initiative (SBTi) and validation of the targets is due in September 2023.

We project that carbon emissions will decrease to **3268** tCO2e by **2030**. This is a reduction of **59%** compared with the base line year 2021.

Progress against these targets can be seen in the graph below:





Carbon Reduction Projects

Completed Carbon Reduction Initiatives:

- 100% renewable electricity at our office in the UK
- Energy saving programs in our UK office, leading to reduced consumption of natural gas.
- 100% renewable electricity at our manufacturing plants from the start 2022
- Full conversion to a new coating process in our Swedish manufacturing plant.
- Solar panels installed at our distribution centre in Germany leading to own generation of electricity.
- Sealing of our sterilization equipment leading to reduced emissions.
- The above-mentioned activities have been completed and is the reason for the reduction seen in 2022.

The carbon emission reduction achieved by these schemes equate to **1718** tCO2e, a **19%** reduction against the **2021** baseline and the measures is in effect as from **2022**.

In the future we hope to implement further measures such as:

- A new coating process at our manufacturing site in Turkey.
- Further energy savings.
- Replacing the cooling systems to those utilizing ammonia as cooling media, to eliminate the emissions of greenhouse gases from these systems.
- Electrification of the car fleet.
- Reduced air freight of products.
